ACKNOWLEDGMENT OF RISK ACCEPTANCE OF RESPONSIBILITY & RELEASE OF LIABILITY

The Arizona statute provides that an equine agent or owner is not liable for injury if the participant took control of the equine prior to injury, if a parent or guardian signed a release on behalf of a minor, if the owner or agent has properly installed suitable tack or the participant has personally tacked the equine, or the owner or agent assigns a suitable equine based on a reasonable interpretation of the person's representation of his or her skills, health and experience with and knowledge of equines. Liability is not limited, however, when an equine owner or agent is grossly negligent or commits willful, wanton or intentional acts or omissions.

I, the undersigned, hereby acknowledge that I have voluntarily applied to engage in an activity of horseback riding with HoofbeatZ USA, LLC.

I understand that the activity of horseback riding involves numerous inherent risks of injury that are an integral part of such an activity. I assume full responsibility for all such risks, including loss of control, collisions, and obstacles, whether they are obvious or not obvious. I and/or my family further understand that an animal, irrespective of its training and usual past behavior and characteristics, may act or react unexpectedly or unpredictably at times, and I also assume such risks.

I understand that I may encounter variations in terrain, which may result in injury or damages. I acknowledge that these are my responsibility, and I assume the risk for these hazards, including breaks, growth, debris, rocks, cliffs and other hazardous surface or surfaces conditions and obstacles, whether they are obvious or not obvious, man-made or natural.

I understand that animals are unpredictable and that the risk of injury is inherent to the activity. I agree to assume all risk of injury or death caused by horseback riding, whatever the cause, except as provided by law.

As consideration for being permitted by HoofbeatZ USA, LLC., to engage in the activity of horseback riding, I do hereby waive my claim and release HoofbeatZ USA, LLC. and all of their owners, officers, members, affiliated organizations, landowners, agent and /or employees for any injury or death caused by or resulting from my participation in the activity of horseback riding.
